#### 286 Apologies for Absence

## 289 Dispensations from members on matters in which they have a Disclosable Pecuniary Interest

### 290 Items in part 1 of the Agenda requiring exclusion of the public

#### 291 Public Speaking

Concerns were raised over parking at the Top of the Town particularly in ice and snow conditions which causes great problems in getting off the main road into the village. There are no restrictions on parking here. The Clerk will contact S Alcock to pursue earlier complaints.

The Civic Trust hope for an objection to the Planning Application for the illuminated sign at St Johns as it is felt that this will distract drivers at the zebra crossing.

Concerns were raised that an email from a resident regarding cigarette ends outside the Conservative Club had been forwarded by the Chairman to the manager of the Club and that her name should have been kept from the Club. Other residents have objected to cigarette ends outside the Conservative Club.

Proposed illuminated sign – **OBJECTION** to the positioning of the sign which could be a distraction to traffic near the zebra crossing with a recommendation the sign be attached to the wall of the building. This was a majority decision.

## HPK/2013/0573 - Miss Molly Whittall, 4 Church Street, Hayfield

Listed building consent for replacement of three existing windows to the rear of the property.

#### NO OBJECTION

NP/HPK/1113/1015 – Carr Meadow Cottages, Glossop Road, Little Hayfield.

Conversion of number 2 Carr Meadow Cottages to form a separate planning unit holiday let. **NO OBJECTION** to the conversion but concerns were raised regarding car parking and vehicle turning.

#### 294 Chairman's Announcements:-

The Chairman attended the AGM of the Allotment Society and reported that all is running very well. No one has come forward wanting a shed despite planning permission being granted. Dead trees have been removed. All the allotments are taken, two were given up but have been taken up. There are plans for a hard-standing area at the top of the site.

The Christmas Tree is in position and the lights will be fitted this evening. The switch on will be this Friday at 7.30pm.

## 295 Committee and Other Reports

## a) Little Hayfield Advisory Group

There was a meeting on 18th November and the following items were discussed:-

The report from Derbyshire Wild Life Trust is still awaited.

The handrail across the footbridge has been repaired but there is still a small gap.

Positioning of the planters - replies have been received from Severn Trent Water, a water main runs under one location and Electricity North West will send a quote for the diversion of power lines. Replies have yet to be received from others.

Members of the LHAC will inspect walling work done by those who have quoted for the work at the Clough. Sally Hodgson will not quote as she is too busy.

The clean up of the Clough area will start on 25th January if permission is given by Council.

It was agreed that the employment of a tree surgeon for a day be placed on the agenda for the next meeting and that quotes should be sought in the meantime.

The proposed scheme for the road opposite the bus shelter takes up 5 or 6 car parking spaces. The landlord of the Lantern Pike objects to this. There is planning permission for a car park at the pub but the brewery does not have the funds for it. Comments on the scheme are needed before 13<sup>th</sup> December 2013. Comments are awaited from residents of Little Hayfield.

**It was RESOLVED** that Derbyshire County Council be asked to have another look at the scheme to reduce the paving area and keep the loss of car parking spaces to a minimum.

The Christmas Lights will be switched on at 7pm on Friday 13<sup>th,</sup> there will be carol singing with mince pies and mulled wine at the Lantern Pike.

lan Turkington of DCC has written stating that there is no budget for work on the footpath. He can do the work but Hayfield Parish Council would have to pay for it.

**Dog Fouling Enforcement:** There will be no requirement for match funding from the Parish Council

Bowden Bridge Interpretation Board: This will now be ordered

**Dungeon Brow:** Still waiting for a reply from Mr Derbyshire regarding moving of the dustbins. **Grit Bins/Stock of Salt:** As reported last month the grit bins round the village have been filled but since then a further two bulk bags have been delivered for holding in stock ready for re-filling

of bins when necessary.

**Footpath 38:** There is a new section of fencing/handrail on the stile steps at the north end of FP 38, right next to the bridge.

**Persimmon Bridge/Wood Lane:** The fence on the right hand side as you walk down to the river is wobbly but again I think it would be the property owners responsibility except for a small section adjacent to the steps.

**Graffiti Removal:** The recent outbreak of graffiti has been reported to High Peak Borough Council for cleaning, also he Police are aware of this and are seeking more information from the public. Please note that HPBC will only remove offensive graffiti from private property, the removal of any other graffiti is the responsibility of the property owner.

Council Tax Benefit Support Grant and Parks Grant 2014/2015: High Peak Borough Council has been asked for for confirmation that the grants Hayfield Parish Council received in 2013/2014 will be paid in the next financial year 2014/2015. A reply is expected in December

**Hayfield Housing Project:** Adele Metcalf of PDNPA has requested that representatives of PDNPA and HPBC come to talk to the Council at a meeting on 8<sup>th</sup> January or 5<sup>th</sup> February next year.
