0121/01 To receive apologies for absence - Nil

**0121/03 Declaration of members' interests** – Cllr. Toft declared an interest in any matters pertaining to Hayfield Allotments, Cllr Bevins excised herself from agenda item 0121/10(e) and the Clerk requested that he be excused from minuting 0121/10(a)

#### 0121/06 Public Speaking – (10 minutes max)

a) Police – PCSO Nield introduced himself as the PCSO covering the Hayfield and New Mills beats. He encouraged Councillors to contact himself with any issues. He made reference to an offence of Criminal Damage that occurred over one night during the Christmas period where 14 vehicles were damaged. Two suspects have been identified with one making admissions during interview and the second yet to be interviewed. He made reference to the continued issues of traffic and congestion along Kinder Road and his hope that current Covid restrictions may reduce this. Councillors thanked him and his

## 0121/07 Minutes of previous meetings

- a) It was resolved to confirm the minutes of the Parish Council meeting of 2<sup>nd</sup> December 2020
- b) The Finance Committee's draft minutes of 16<sup>th</sup> December 2020 were noted.

**0121/08 Chair's announcements** – The Chair referred back to the incident of Criminal Damage but then contrasted that with recent examples of the actions of 'good' people in the village. He drew attention to an incident of a Chinley resident losing her purse and it being found and returned unfortunately with money missing. A social media campaign raised £800 which returned all the lost money and allowed a donation of £500 to 'Crossroads'. He also referred to the community effort to trace a high risk missing from home including Mountain Rescue and local publicans providing refreshment for those engaged in the search. He concluded it was heartening to live in an area where so many people go out of their way to help others

## 01231/10 Planning – It was resolved to;

a) Object to HPK/2020/0219 – Revision – Land Adjacent 80 New Mills Road, Hayfield – Residential development with associated access and landscaping.

As the Parish Council has continuing concerns and strongly object to this application: When entering the village from the West the isolated detached property would be prominent and overwhelm the listed barn as well as being prominent from the Sett Valley Trail. The terrace would be less intrusive but none the less impacts on both the open aspect and listed barn.

The 3 terraced properties are adjacent to a narrow footpath, in addition to highways issues detailed below, now that there is so much internet trading, delivery drivers will no doubt park on the pavement where the splays are dubious.

Additional to the above comment, the location of 8 refuse bins on green/brown bin days, would make this hazardous for pedestrians.

We would question the connection to mains sewerage, the applicant's previous planning permission for 64+66 New Mills road stated that the houses would be connected to mains sewerage, however because of the topography this was not possible and a septic tank had to be installed. At this site we have concerns how a septic tank would be serviced and the effect on roots of trees including one subject to a TPO.

The highways issues are numerous:

Quoted splays remain the same as previous despite change to the site entrance.

The quoted splays (of which we are doubtful) appear to take no account of the walls, tree and lamppost, indeed the walls are higher than a standard car with an inevitable impact on splay.

There is a bus stop and double white lines (already an issue) almost opposite the site entrance.

On the balance of benefit, we believe that this application would be detrimental to the village and residents.

We would welcome the opportunity to comment further once the report from County Highways is available.
