a) Derbyshire County Councillor Clarke sent apologies to the meeting having asked that it be made known that County Councillors Community Fund has been doubled due to current 'cost of living crisis'. HPBC Councillor Lawson commented on the now frequent of traffic enforcement officers on Kinder Road.

HPBC Councillor Ashton informed the meeting about the planned refurbishment and extension of New Mills Recreation Centre to facilitate larger classes for certain activities.

- b) A member of the public spoke about the Hayfield Football and Community Sports Club's current and past campaigns to improve facilities for local youth at the Bank Vale Road Site. He referred to a document sent to the Council outlining current planning issues and in particular the Football Associations request to place a 'charge' on the Bank Vale Road land. He informed the council that they will be receiving a number of documents circulated via the clerk and requested councillors consider them in depth to seek a way forward. He highlighted the danger that as a worst-case scenario the club may have to move and asked for the Councils patience.
