1222/01 To receive apologies for absence – Cllrs. L Bevins, D Toft & J Wilson

1222/05 Agenda items to be taken with the public excluded – It was resolved to hear 1222/15 NALC national pay scales agreement (April 2022) with the public excluded as it related to personal financial information pertaining to an employee

1222/06 Public Speaking – (10 minutes max)

- a) Derbyshire County Councillor Clarke updated the meeting on a number of issues
 - All e-mails raising concerns about a new 'snack bar' facility on the Sett valley Trail car park
 have been forwarded to the office concerned. This is a new venture from the Countryside
 Service (DCC) to raise revenue, but all accepted it had not gone smoothly. To address the
 issue of noise the facility will now link directly to the ranger office for power and not use an
 external generator.
 - DCC have an additional £100,000 to the Government 'Warm Spaces Grant" which means that applicants can now apply for up to £1,000 for the running of warm spaces.

- Consultation re the 'Combined Authority' has gone live online and she recommended as many parishioners take part as possible.
- High Peak Borough Councillor Lawson thanked DCC Clarke for clarification re the 'snack bar' High Peak Borough Councillor Ashton drew the meetings attention to insulation funding the Borough had received and that details are available to parishioners and directed those interested to the Borough Councils website.
- b) A member of the public spoke referring to the DCC 'Snack Bar' stating that 10-15 years previously she had proposed a similar initiative that had been rejected. Her point being that a similar income had been available for 10-15 years.
 - A member of the public update the meeting with an update regarding the Sustainable Hayfield 'Home Energy MOT' scheme. There have been 90 requests for visits equating to 10% of households in the Parish. Visits will be undertaken throughout December and January. Sustainable Hayfield will be seeking additional funding to continue the scheme and the Council were asked if they knew of any information that could assist. Feedback to date has been extremely positive A member of the public referred to the DCC 'Warm Home Grant' and said that the conditions attached meant that the kind of support Hayfield volunteers offered didn't fit the criteria i.e., it was too stringent.
